
HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 383

The Board of Directors of Harris County Municipal Utility District No. 383 will hold a regular meeting on **Wednesday, July 3, 2024, at 12:00 p.m.**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, Pecos Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Receive comments from the public.
2. CONSENT AGENDA: The following items are considered routine by the Board and will be enacted by one motion. No separate discussion will occur on these items unless a Board member so requests, in which event the item will be removed and placed on the Non-Consent Agenda.
 - a. Approve minutes.
 - b. Development in the District and elsewhere in Gleannloch Farms.
 - c. Tax assessment and collection matters, including delinquent tax collections and payment of tax bills.
 - d. Financial and bookkeeping matters, including payment of bills, review of investments, and budget comparison.
 - e. Operation of District facilities, including:
 - i. billings, repairs and maintenance, customer correspondence, and message language on water bills;
 - ii. North Harris County Regional Water Authority matters; and
 - iii. sanitary sewer video inspection program and repairs.
 - f. District park matters, community improvement projects, and related coordination with community association.
 - g. Channel and pond maintenance, including detention and drainage facilities report and proposals for work.
 - h. District website and communication matters.

- v. emergency repairs to water well no. 1;
- vi. update on application for renewal of Texas Pollutant Discharge Elimination System Permit;
- vii. deeds, easements, execution of plats, consents to encroachment requests for annexation and/or service, utility commitment letters, and wastewater service contracts;
- viii. capital improvement plan, including project funding;
- ix. Phase 4 sanitary sewer cleaning and televising;
- x. District drainage matters;
- xi. update on bond application no. 12;
- xii. NewQuest detention pond; and
- xiii. other engineering matters.
- h. Additional tax matters including
 - i. adopt Resolution Regarding Development Status for 2024 Tax Year;
- i. Additional financial and bookkeeping matters, including:
 - i. discuss Association of Water Board Directors summer conference, approve reimbursement of eligible expenses, and authorize attendance at winter conference.

 - i. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
- k. Approve Interlocal Agreement with Harris-Galveston Subsidence District for the Water Conservation School Program.
- l. Authorize renewal of District's insurance policies, including review of engineer's list of District facilities to be insured.
