

## NOTICE OF MEETING

### HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 383

The Board of Directors of Harris County Municipal Utility District No. 383 will hold a regular meeting on **Wednesday, August 6, 2025, at 12:00 p.m.**, at the offices of Municipal Accounts & Consulting, L.P., 1281 Brittmoore Road, Houston, Texas 77043, to discuss and, if appropriate, act upon the following items:

1. Receive comments from the public.
2. CONSENT AGENDA: The following items are considered routine by the Board and will be enacted by one motion. No separate discussion will occur on these items unless a Board member so requests, in which event the item will be removed and placed on the Non-Consent Agenda.
  - a. Approve minutes.
  - b. Development in the District and elsewhere in Gleannloch Farms.
  - c. Tax assessment and collection matters, including delinquent tax collections and payment of tax bills.
  - d. Financial and bookkeeping matters, including payment of bills, review of investments, and budget comparison.

    - ii. sanitary sewer video inspection program and repairs.
  - f. District park matters, community improvement projects, and related coordination with community association.
  - g. Channel and pond maintenance, including detention and drainage facilities report.
  - h. District website and communication matters.

  - v. update on application for renewal of Texas Pollutant Discharge Elimination System Permit;
  - vi. deeds, easements, execution of plats, consents to encroachment requests for annexation and/or service, utility commitment letters, and wastewater service contracts;
  - vii. capital improvement plan, including project funding;
  - viii. District drainage matters;
  - ix. NewQuest detention pond; and
  - x. other engineering matters, including:
    - aa. nutria removal; and
    - bb. Boudreaux Road realignment.

  - i. Phase 1 sanitary sewer manhole survey;

  - iv. hearing on termination of water and sewer service to delinquent customers and authorize termination of service; and
  - v. write-off of delinquent charges.
- n. Approve Interlocal Agreement with Harris-Galveston Subsidence District for the Water Conservation School Program, if appropriate.
- o. Reports from Directors and District consultants on District matters.
